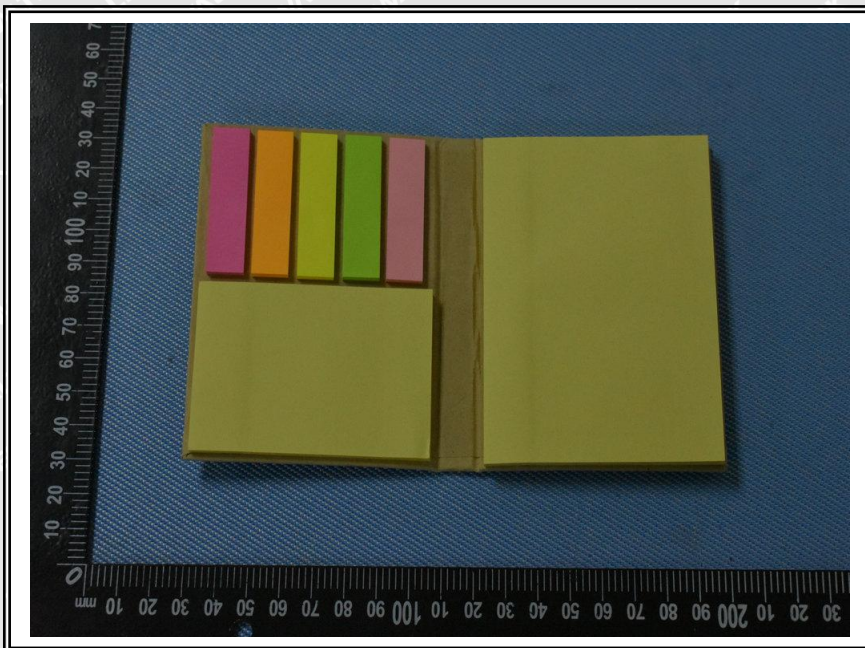

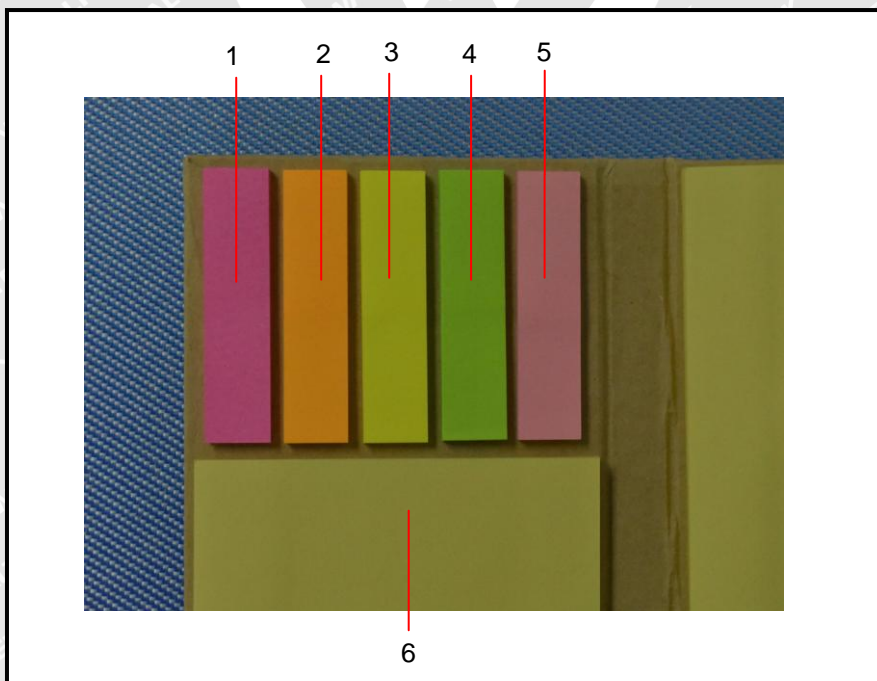

- No.7: Brown paper shell with silvery printing

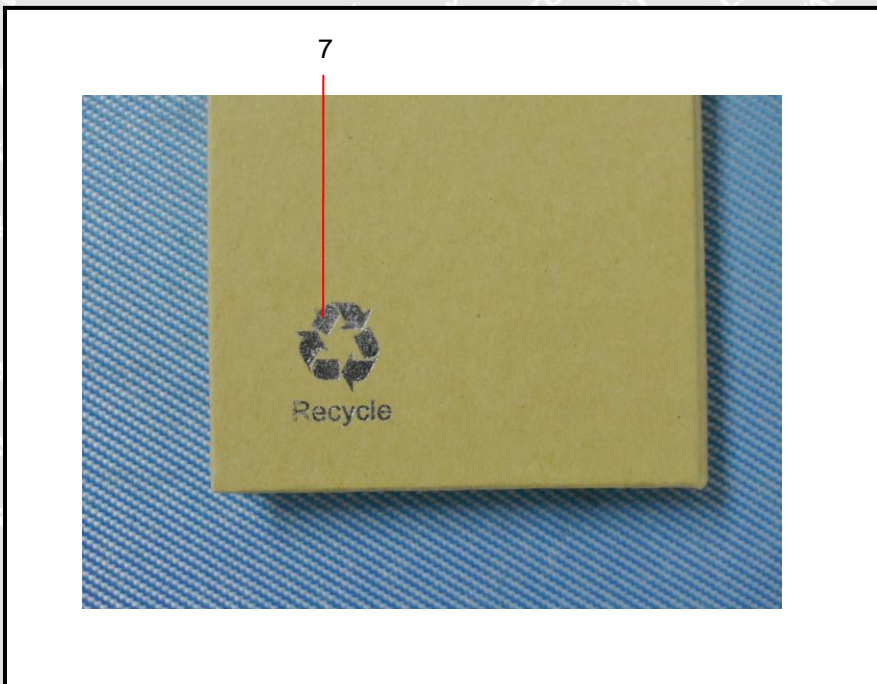
